Accounts are considered past due if not paid thirty (30) days from the date of delivery at which time credit terms will be revoked. Invoices are received at the time of delivery. Bay Area Beverage reserves the right to place an account on credit hold for violations of ABC credit laws and/or nonconformance of company policies and procedures. All business operating on a temporary license must pay COD in accordance with ABC Law. Dishonored checks are subject to a \$35.00 per item fee, removal of credit terms, as well as being subject to collection fees and damages pursuant to California Civil Code section 1719(a).

For Your Information: A person may be guilty of a misdemeanor under Revenue and Taxation Code section 6094.5 if the purchaser knows at the time of purchase that he or she will not resell the purchased item prior to any use (other than retention, demonstration, or display while holding it for resale) and he or she furnishes a resale certificate to avoid payment to the seller of an amount as tax. Additionally, a person misusing a resale certificate for personal gain or to evade the payment of tax is liable, for each purchase, for the tax that would have been due, plus a penalty of 10 percent of the tax or \$500, whichever is more.
